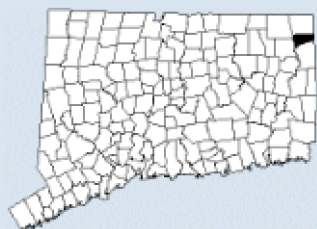

### Narratives

#### School District Improvement Plans and Parental Outreach Activities

The Putnam Board of Education prioritizes student achievement for all. This is achieved through a collaborative approach between educators, support staff, and experts. Innovative teaching strategies, aligned curriculum, and effective assessments are key components.

A dedicated Professional Development Committee, composed of teachers and administrators, designs in-service programs aligned with board goals and individual teacher needs. Teachers actively participate in their own professional growth by setting goals linked to their evaluations. Additionally, the district collaborates with reading and writing specialists to improve instruction for all students.

To address individual learning needs, the district implements a comprehensive, Scientifically Research-Based intervention (SRBI) plan, encompassing both academic and behavioral support. Monthly after-school meetings are dedicated to professional development, further supporting teacher growth.

Data-driven decision-making is a cornerstone of Putnam's approach. Teachers utilize formative and summative assessments to refine curriculum, plan instruction, and monitor student progress. To improve attendance and support student well-being, the district collaborates with various local and state agencies, including EASTCONN, LEARN, TEEG, and the Groton Center. Initiatives like the morning late bus run and High Dosage Tutoring grant exemplify this commitment.

Additionally, school-based health clinics, run in collaboration with an outside health agency, address student behavioral needs. Increased support for special education programs is evident through the addition of a Board Certified Behavior Analyst (BCBA) and four Registered Behavior Technicians (RBTs).

The Board of Education actively seeks input from stakeholders through its five-year strategic plan, developed with community and school representatives. Each school contributes to the district's goals by submitting annual school improvement plans.

Our PTO also plays a vital role in supporting our students. They meet monthly with administration and teachers to plan events throughout the year, fostering a strong sense of community and family engagement in our schools.

#### Efforts to Reduce Racial, Ethnic and Economic Isolation

The Putnam Board of Education prioritizes two key goals: fostering equity and community involvement. This includes advocating for families, enhancing communication, and building strong partnerships. Additionally, they aim to support the social and emotional needs of students and staff through coordinated programs and services. To achieve these goals, Putnam Public Schools offers a diverse range of opportunities that promote interaction among students from various racial, ethnic, and economic backgrounds. Collaboration with the Putnam Family Resource Center and Recreation Department helps reduce economic isolation by making after-school, weekend, and enrichment activities accessible to all students.

The district further expands student and family horizons by funding field trips to museums, zoos, theaters, and more. Additionally, all students in middle and high school can participate in team sports. The Gender-Sexuality Alliance (GSA) club at Putnam High School which is composed of students from all backgrounds and exemplifies the district's commitment to inclusivity. The group co-sponsored and organized a successful town-wide Quiet Corner Pride Event open to everyone in our region.

Putnam Middle School participates in an inter-district grant, exposing students to diverse student populations. Students also regularly interact with community organizations through required community service for graduation, fostering a sense of engagement.

### **Equitable Allocation of Resources among District Schools**

The Putnam School District prioritizes quality education for all students. To achieve this core goal, the Board of Education offers diverse programs and opportunities. We utilize a needs-based budgeting approach, where allocations are determined by student requirements rather than past formulas. During this process, teachers collaborate with building principals to identify needs, and administrators work with the Board to ensure all district needs are met.

Draft budgets are then presented to the community for feedback and revisions. Our Board of Finance finalizes the budget allocation amount for a vote by taxpayers at the annual Town meeting.
