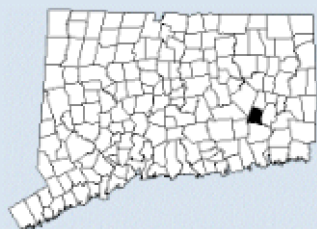

School District Improvement Plans and Parental Outreach Activities

All staff have continued training and other efforts to utilize tiered instruction and assessment with struggling students before engaging in the special education process.

We actively monitor student attendance and send communications to parents regarding those concerns.

Our special education staff is continuing its training in the State's new system for writing Individual Education Plans - CT-SEDS. This training is providing an opportunity to recalibrate our district's consistency with the Planning and Placement Team process as well as other tiered intervention services.

The district is also engaged in curriculum revision and developing a plan consistent with the State's new guidance for educator and leader evaluation.

Parents are often invited to serve on several school committees including climate and safety. They are also often included as members of our staff hiring committees. Additionally, parents take an active role in organizing and planning field trips and activities for the 8th grade graduating classes.

Efforts to Reduce Racial, Ethnic and Economic Isolation

Through literature, social studies, and the social-emotional learning curriculum, students were exposed to information about different cultures, customs, and traditions, helping them to understand both the diversity and commonalities represented in the community and the world.

With the use of state and federal grants, Fields Memorial School was able to ensure that every student continues to have access to a device, charger, and wifi. A variety of uses for this technology in the classroom and beyond are evening the playing field for all students regardless of economic circumstances.

Equitable Allocation of Resources among District Schools

Bozrah has only one school in the district. FMS is a PK-8 school with approximately 163 students. Secondary students attend surrounding high schools on a tuition basis. All funds provided through the annual budget process, grants, & donations go directly to the operational & educational costs of FMS. Our district-funded interventionist positions have helped to ensure that all students' needs are being met - focusing on the efforts to recover from COVID learning loss.
