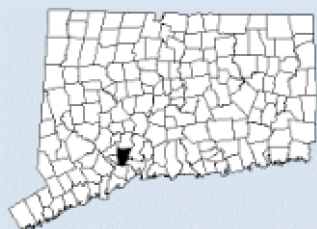

### Narratives

#### **School District Improvement Plans and Parental Outreach Activities**

Planning for continuous school district improvement has been guided by the district's Strategic Plan. District administration, faculty, and staff developed and implemented a variety of activities to support students' social and emotional development, including family outreach to engage all parents/guardians. For this final funding year, Covid-19 grant funds were utilized to increase special education and psychologist services for the school year to support students and families struggling with learning needs. Additional district improvement continues to celebrate culturally responsive education at the elementary level, with specific professional learning applied by grade-level teams. Finally, led by the District Safe School Climate Coordinator, District administration and wellness staff implemented student-specific plans to prevent truancy and chronic absenteeism. Ongoing parent communications, use of technology platforms for notification (daily classroom communication often occurs through a technology platform), and in-person parent meetings are held in an ongoing manner to proactively address negative attendance patterns. Community forums were held this year around the areas of ELA and mathematics in an effort to further establish family/school engagement and a districtwide survey was administered with the aim of seeking strategies to aid in improving communication.

#### **Efforts to Reduce Racial, Ethnic and Economic Isolation**

Approximately 2% of learners in the Woodbridge School District were Open Choice participants in this 2024-2025 school year. This partnership with New Haven through Open Choice directly and indirectly contributes to reducing racial, ethnic, and economic isolation. All District teachers participated in professional development focused on culturally responsive teaching and learning, which built on prior years' professional learning. The District began implementing practices outlined in the required CSDE required Increasing Educator Diversity recruitment and hiring plan. Additionally the district attended minority staff recruitment events held at local universities.

### **Equitable Allocation of Resources among District Schools**

The Woodbridge School District is comprised of one very large elementary school building which allocates district resources at Beecher Road School to support the needs of approximately 900 students. Particular emphasis is placed on students with identified special needs, students who are English language learners, students in need of scientific research-based interventions (as identified through the MTSS screening and intervention process), and students who are talented and/or gifted through multiple screeners. Formal budget development begins at the teacher and team level and proceeds through school administrators working with the Superintendent and the Director of Business Services and Operations to support District and school goals and ongoing excellence. CSDE Title Grants are secured and applied to further ensure that student learning needs are addressed.
