Overview

This report provides tuition expenditures for resident students outplaced to private facilities or enrolled in other districts' schools. Note that outplaced tuition types with low pupil counts are not listed on the report, however their amounts are included in totals. If no detail lines are available, this report will not be available. Dollar amounts are rounded to the nearest whole dollar. Amounts may not sum exactly due to rounding.

How to Use this Report

Use the dropdowns to generate results for this report. Export the results to a .csv file by clicking **Export .csv file**.

- To view Per Pupil Expenditures for Outplaced Students for the State as a whole, select "State of Connecticut" from the District dropdown, and click Submit.
- To view Per Pupil Expenditures for Outplaced Students for all districts, select "All Districts" from the District dropdown, and click Submit.
- To view Per Pupil Expenditures for Outplaced Students for a single district, select the district from the District dropdown, and click Submit.

Inclusion/Exclusion Rules

All reports present PPE for free elementary and secondary education, including both regular and special education. Reports exclude expenditures for food services not funded by local funds, debt, capital, adult education, community services, and state contributions to teachers' retirement.
